FY18 INTERIM DIVIDEND – ALLOTMENT AND ISSUE OF NEW SHARES FOR SCRIP DIVIDEND SCHEME

Oversea-Chinese Banking Corporation Limited (the "Bank") wishes to announce that it has today allotted and issued 62,933,078 new ordinary shares (the "New Shares") to ordinary shareholders ("Members") who had elected to participate in the Scrip Dividend Scheme (the "Scheme") in respect of the interim one-tier tax-exempt dividend for the financial year ending 31 December 2018 (the "FY18 Interim Dividend") of 20 cents per ordinary share. Entitlements to the FY18 Interim Dividend were based on shares held by Members as at 5.00 p.m. on 17 August 2018.

The participation rate for the Scheme was 76.2% of shareholdings. Following the allotment and issuance of the New Shares, the number of issued ordinary shares of the Bank will increase by 1.5% to 4,256,770,207 shares. The New Shares will rank *pari passu* in all respects with the existing ordinary shares of the Bank and are expected to be listed and credited on 9 October 2018.

Members who did not participate in the Scheme will be paid the FY18 Interim Dividend in cash on 8 October 2018.

Odd-lot Trading

Following the listing and crediting of the New Shares on 9 October 2018, Members who wish to dispose of or acquire odd lots of shares should contact their brokers to do so. Alternatively, Members may also contact OCBC Securities Private Limited who will facilitate odd lot trading (that is, up to 99 shares in any one contract) at a concessionary brokerage fee of S\$15 (excluding GST) per contract for a period of one month from 9 October 2018.
