Why do I need to provide my full NRIC number?	This is to enable SATS to verify that you are a shareholder.
Who can pre-register for the live AGM proceedings?	Only shareholders of SATS, will be able to pre-register to watch the live audio-visual webcast and/or listen to the live audio-only stream.
Can I pre-register my representative for the live AGM proceedings?	No, the live audio-visual webcast and live audio-only stream are only available to shareholders of the Company.

You will need to <b>appoint the Chairman of the Meeting as your proxy</b> to vote on your behalf at the AGM, in accordance with the instructions on the proxy form. Specific instructions must be given as to voting, o abstentions from voting, in respect of a resolution in the proxy form failing which the appointment of the Chairman of the Meeting as proxy for that resolution will be treated as invalid.
	You can submit an instrument appointing the Chairman of the Meeting as proxy in the following manner:

	(c) By post. Shareholders may submit their questions by post to the Company's Share Registrar, M & C Services Private Limited, at 112 Robinson Road #05-01, Singapore 068902.
	When sending in your questions via email or by post, please also provide us with the following details:
	<ul> <li>your full name;</li> <li>your address; and</li> <li>the manner in which you hold shares in SATS (e.g., via CDP, CPF, SRS and/or scrip).</li> </ul>
	All questions must be submitted by <u>11.00 a.m. on 21 September</u> <u>2020</u> .
	You will not be able to ask questions at the AGM during the live audio- visual webcast or live audio-only stream.
