## General

In addition, in the case of units entered in the Depository Register, the Manager may reject any Proxy Form appointing the Chairman of the AGM as proxy lodged if the unitholder, being the appointor, is not shown to have units entered against his/her name in the Depository Register at least 72 hours before the time appointed for holding the AGM, as certified by The Central Depository (Pte) Limited to the Manager.
