**STATUS UPDATE OF REFINANCING EXERCISE**

*Capitalised terms not otherwise defined herein shall have the meanings respectively ascribed to them in the Prospectus dated 13 January 2017 as well as the announcements dated 20 January 2021, 5 July 2021 and 20 July 2021.*

The board of directors (the "**Board**") of Dasin Retail Trust Management Pte. Ltd. (the "**Trustee-Manager**"), as trustee-manager of Dasin Retail Trust (the "**Trust**") refers to the Extension of Offshore and Onshore Facilities announcement dated 20 July 2021 wherein it was announced that the tenure of both the Offshore Facilities and Onshore Facilities were further extended to 19 December 2021.

The Trustee-Manager wishes to update that the lenders of both the Onshore and Offshore Facilities have granted an extension of 3 months from 20 December 2021 to allow lenders more time to discuss new requests made by minority lenders.

The Trustee-Manager hopes to see a successful conclusion to the refinancing exercise soon and will make appropriate announcements in the event of any further material developments.
