UBS AG, Singapore Branch (the "Stabilising Manager"), as the stabilising manager, had in the initial public offering of the Company ("IPO") over-allotted an additional 24,276,300 Shares, which were covered by 24,276,300 Shares borrowed by the Stabilising Manager from SeaTown Private Capital Master Fund pursuant to the share lending agreement entered into between SeaTown Private Capital Master Fund and UBS AG, Singapore Branch.

SeaTown Private Capital Master Fund had also granted the underwriters for the IPO an over-allotment option (the "Over-allotment Option") exercisable by the Stabilising Manager, in full or in part, on one or more occasions, to purchase from SeaTown Private Capital Master Fund up to an aggregate of 24,276,300 Shares at the IPO offering price of S\$0.76 per Share, solely to cover the over-allotment of Shares made in connection with the IPO.

The Stabilising Manager had on 7 August 2026 exercised the Over-allotment Option in respect of 3,027,200 Shares. Accordingly, following completion of the exercise of the Over-Allotment Option on 12 August 2026, SeaTown Private Capital Master Fund ceased to have an interest in the 3,027,200 Shares.

On 12 August 2026, the Stabilising Manager returned 21,249,100 of the borrowed Shares to SeaTown Private Capital Master Fund, upon which SeaTown Private Capital Master Fund's deemed interest in such 21,249,100 Shares became a direct interest.
