A member who wishes to submit an instrument of proxy must first download, complete and sign the proxy form for the adjourned Annual General Meeting, before submitting it by post to the address provided above, or before scanning and sending it by email to the email address provided above.

In view of the current COVID-19 situation and the related safe distancing measures which may make it difficult for members to submit completed proxy forms by post, members are strongly encouraged to submit completed proxy forms electronically via email.

- 5. The instrument appointing the Chairman of the Meeting as proxy must be under the hand of the appointor or of his attorney duly authorised in writing. Where the instrument appointing the Chairman of the Meeting as proxy is executed by a corporation, it must be executed either under its seal or under the hand of a director or an officer or attorney duly authorised. Where the instrument appointing the Chairman of the Meeting as proxy is signed on behalf of the appointor by an attorney, the power of attorney or other authority under which it is signed (if applicable) or a duly certified copy thereof must (failing previous registration with the Company), if the instrument appointing the Chairman of the Meeting as proxy is submitted by post, be deposited with the instrument or, if the instrument appointing the Chairman of the Meeting as proxy is submitted electronically via email, be emailed with the instrument, failing which the instrument may be treated as invalid.

The Company shall be entitled to, and will, treat any valid proxy form appointing the Chairman of the Meeting or other person(s) as proxy(ies) which was delivered by a member to the Company before 13 April 2020 as a valid proxy form appointing the Chairman of the Meeting as the member's proxy to attend, speak and vote at the adjourned Annual General Meeting if:
 - (a) the member had indicated how he/she/it wished to vote for or vote against or abstain from voting on each resolution; and
 - (b) the member has not withdrawn the proxy form.
- 7. A member may withdraw a proxy form appointing the Chairman of the Meeting or other person(s) as proxy(ies) by sending an email to proxyform@trustedservices.com.sg to notify the Company of the withdrawal, by 4.00 p.m. on 7 June 2020, being 72 hours before the time appointed for holding the adjourned Annual General Meeting.
- 8. Submission by a member of a valid proxy form for the adjourned Annual General Meeting appointing the Chairman of the Meeting as proxy by 4.00 p.m. on 7 June 2020, being 72 hours before the time for holding the adjourned Annual General Meeting, will supersede any previous proxy form appointing a proxy(ies) submitted by that member

The Company shall be entitled to reject the instrument appointing the Chairman of the Meeting as proxy if it is incomplete, improperly completed or illegible or where the true intentions of the appointor are not ascertainable from the instructions of the appointor specified in the instrument appointing the Chairman of the Meeting as proxy (including any related attachment). In addition, in the case of a member whose shares are entered in the Depository Register, the Company may reject any instrument appointing the Chairman of the Meeting as proxy if the member, being the appointor, is not shown to have shares entered against his name in the Depository Register as at 4.00 p.m. on 7 June 2020, being 72 hours before the time appointed for holding the adjourned Annual General Meeting, as certified by The Central Depository (Pte) Limited to the Company.
