Aoxin Q & M to Establish New Dental Hospital in Shenyang in Collaboration with the Shenhe District People's Government

- **Memorandum of understanding signed with the Shenhe District People's Government at the 11th Singapore-Liaoning Economic and Trade Council in Shenyang**
- **Investment of RMB35 million in a new dental hospital with a gross floor area of 2,430 square metres in Shenhe District, Shenyang**
- **Property acquisition completed and interior fit-out underway, with soft opening targeted by end of September 2026**
- **New dental hospital expected to be staffed by more than 80 healthcare professionals and 20 support staff upon commencement of operations**

Singapore, 12 August 2026 – Aoxin Q & M Dental Group Limited (“**Aoxin Q & M**” or the “**Company**”, and together with its subsidiaries, the “**Group**”) (SGX: 1D4) today announced that it has entered into a memorandum of understanding (“**MOU**”) with the Shenhe District People's Government for the establishment of a new dental hospital in Shenyang, the capital of Liaoning Province, in the People's Republic of China (“**PRC**”).

The MOU was signed in Shenyang at the 11th Singapore-Liaoning Economic and Trade Council (“**SLETC**”), the bilateral platform through which Singapore and Liaoning Province advance economic and trade cooperation.

A New Dental Hospital in Shenhe District

While retaining its existing dental centres, the Group is investing an estimated RMB35 million in the new hospital, comprising the acquisition of the property at No. 88-7 Wenhua Road, Shenhe District, Shenyang, which has been completed, and the interior fit-out now under way. The new dental hospital has a total gross floor area of 2,430 square metres and is scheduled for a soft opening by end of September 2026.

Upon commencement of operations, the hospital is expected to be staffed by more than 80 healthcare professionals and 20 support staff, offering endodontic treatment, periodontal disease prevention and treatment, restorative dentistry, dental implants and orthodontics.

An Established Platform in Liaoning Province

Shenyang Aoxin Q & M Stomatology Hospital Co., Ltd., a subsidiary of the Group, is an accredited provider under the Liaoning Provincial and Shenyang Municipal medical insurance programmes, and holds licences issued by the Shenyang Municipal Health Commission covering medical advertising, radiation safety and medical device manufacturing. Its clinical team is led by experienced specialists, and the Group's wider network spans multiple cities across Liaoning Province.

Mr Chua Ser Miang, the Non-Executive and Non-Independent Chairman of Aoxin Q & M, said:

“Shenyang has been the Group’s home market since inception, and this new hospital represents a significant deepening of our commitment to it. Working alongside the Shenhe District People’s Government gives us a strong local foundation to build upon.”

“A purpose-built facility of this scale allows us to bring specialist care, modern equipment and an experienced clinical team together under one roof, and better serve our patients.”

“We believe this investment will support sustainable value creation for our shareholders over time.”
