The first SK Bullion store will be opened in August 2016 at Clifford Centre, strategically located in the heart of Raffles Place, the financial district of Singapore.

Headquartered in Singapore, one of the world's safest jurisdictions and strategically located at the heart of international trade flow, SK Bullion is well poised to tap into the opportunities in the global bullion industry.
