#### 57th ANNUAL GENERAL MEETING TO BE HELD ON 22 JANUARY 2021

- 1. **Background**. Frasers Property Limited (the "Company" or "FPL") refers to:
  - (a) the COVID-19 (Temporary Measures) Act 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, inter alia, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
  - (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order") which sets out the alternative arrangements in respect of, inter alia, general meetings of companies; and
  - (c) the joint statement by the Accounting and Corporate Regulatory Authority, Monetary Authority of Singapore and Singapore Exchange Regulation of 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020 and 1 October 2020) which provides additional guidance on the conduct of general meetings during the period from 27 March 2020 to 30 June 2021.
- Date, time and conduct of Annual General Meeting. FPL is pleased to announce that pursuant to the Order, its 57<sup>th</sup> Annual General Meeting ("AGM") will be convened and held by way of electronic means on <u>Friday</u>, 22 January 2021 at 9.30 a.m. (Singapore time).
- 3. **Notice of AGM, proxy form**. The Notice of AGM and proxy form will be sent to shareholders by electronic means via publication on the Company's website and on the SGX website<sup>1</sup>. For convenience, printed copies of these documents, and this announcement, will also be sent by post to shareholders.

- 4. **No personal attendance at AGM**. Due to the current COVID-19 situation in Singapore, **shareholders will not be able to attend the AGM in person**.
- 5. **Alternative arrangements for participation in the AGM**. Shareholders may participate in the AGM by:
  - (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
  - (b) submitting questions in advance of the AGM; and/or
  - (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.

There will be no live voting or live Q&A at the AGM.

- 6. **Persons who hold shares through relevant intermediaries**. Persons who hold FPL shares through relevant intermediaries (as defined in section 181 of the Companies Act, Chapter 50), other than CPF and SRS investors, and who wish to participate in the AGM by:
  - (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
  - (b) submitting questions in advance of the AGM; and/or
  - (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM,

should contact the relevant intermediary through which they hold such shares as soon as possible in order for the necessary arrangements to be made for their participation in the AGM.

## Steps for pre-registration, pre-submission of questions and voting at the AGM

Shareholders will be able to observe and/or listen to the AGM proceedings through a live audio-visual webcast or live audio-only stream via their mobile phones, tablets or computers, submit questions in advance of the AGM and vote by appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.

**Deadline to submit questions**. All questions must be submitted by **9.30 a.m. on 19 January 2021**.

We will address all substantial and relevant questions received at least 72 hours before the AGM prior to or during the AGM. The Company will publish the responses to the substantial and relevant questions which the Company is unable to address during the AGM, on the Company's website and on SGXNet prior to the AGM. We will publish the minutes of the AGM on the Company's website and on SGXNet, and the minutes will include the responses to the substantial and relevant questions which are addressed during the AGM.

3. Submit instruments appointing Chairman of the Meeting as proxy to vote

Shareholders will not be able to vote at the AGM live during the webcast or audio-stream. Shareholders (whether individual or corporate) who pre-register to observe and/or listen to the AGM proceedings and wish to vote on the resolutions to be tabled at the AGM must appoint the Chairman of the Meeting as their proxy to attend, speak and vote on their behalf at the AGM, in accordance with the instructions on the instrument appointing a proxy.

**Specific voting instructions to be given**. Where shareholders (whether individual or corporate) appoint the Chairman of the Meeting as their proxy, they must give specific instructions as to voting, or abstentions from voting, in respect of a resolution in the instrument appointing a proxy, failing which the appointment of the Chairman of the Meeting as proxy for that resolution will be treated as invalid.

**Submission of instruments of proxy**. The instrument appointing the Chairman of the Meeting as proxy must be submitted in the following manner:
