ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN

3 December 2014 - Mapletree Commercial Trust Management Ltd., as manager (the "Manager") of Mapletree Commercial Trust ("MCT") wishes to announce that it will issue 3,906,319 new units in MCT ("Units") at an issue price of S\$1.4049 per new Unit pursuant to MCT's distribution reinvestment plan ("DRP") in respect of MCT's distribution for the Second Quarter Financial Year 2014/2015 from 1 July 2014 to 30 September 2014 ("2Q FY14/15 Distribution") on 4 December 2014.

The new Units will be credited by 4 December 2014 to securities accounts of MCT unitholders ("**Unitholders**") who have elected to participate in the DRP. The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited (the "**SGX-ST**") at 9:00 a.m. on 4 December 2014.

Following the issue of the new Units, the total number of MCT Units in issue has increased from 2,099,877,048 to 2,103,783,367.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the 2Q FY14/15 Distribution in cash on 4 December 2014.
