SINGAPORE, October 13, 2022 – GSS Energy Limited (SGX: 41F) ("GSS Energy" or the "**Company**", and together with its subsidiaries, the "**Group**") is pleased to have hosted the Minister for Trade and Industry of Singapore, Mr. Gan Kim Yong, at its factory in Batam, Indonesia. The factory in Batam, Indonesia, which was started since 1991, is one of the Group's

manufacturing factories across China, Singapore and Indonesia, and provides electronic manufacturing services, such as plastic injection molding, printed circuit board assembly and product assembly. With a factory space of approximately 28,000 square meters, the factory in Batam, Indonesia, is the Group's flagship manufacturing hub, where assembly and production of its electric two-wheelers will also take place all under one roof.

Through its wholly owned subsidiary, Giken Mobility Ltd, GSS Energy will manufacture its flagship electric two-wheeler at its factory in Batam, Indonesia, under the "Iso" brand. Giken Mobility Ltd is currently the exclusive global licensee and manufacturer of the Italian heritage motorcycle brand "Iso". The factory visit included an orientation of the manufacturing plant and a showcase of the electric two-wheelers and the range of other products produced in the facility.

Enterprise Singapore has supported Giken Mobility Ltd through its Enterprise Development Grant for the research and development of the electric two-wheelers, as well as helped Giken Mobility Ltd access and expand into international markets.

Mr. Sydney Yeung, Chief Executive Officer of GSS Energy, annotated: "We are delighted to host Minister Gan at our manufacturing facility in Batam, Indonesia. As the production of our first electric two-wheeler gets underway, we are more motivated than ever to realize our vision for the future of transportation to stay future-ready and strengthen our innovative capabilities."
