ISSUE PRICE OF NEW UNITS PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE DISTRIBUTION PERIOD FROM 1 JULY 2024 TO 31 DECEMBER 2024

Elite UK REIT Management Pte. Ltd., as manager of Elite UK REIT ("**REIT**", and the manager of REIT, the "**Manager**"), wishes to announce that further to the announcement dated 10 February 2025 in relation to the application of a distribution reinvestment plan (the "**DRP**") to the distribution of GBP 1.47 pence per unit in REIT ("**Unit**") for the period from 1 July 2024 to 31 December 2024 (the "**Distribution**"), the issue price of the new Units to be issued under the DRP in respect of the Distribution is GBP 0.2981 per Unit.

The issue price represents a 2% discount to the volume-weighted average traded price per Unit ("VWAP") for all trades on Singapore Exchange Securities Trading Limited (the "SGX-ST") for each of the Market Days¹ during the period of 10 Market Days prior to and ending on the record date on 18 February 2025. The number of Units to be issued to unitholders of Elite UK REIT ("Unitholders") pursuant to the DRP shall be rounded down to the nearest whole Unit, fractional entitlements to be disregarded.

The Notices of Election² are expected to be dispatched to all eligible Unitholders on or around 3 March 2025.
