**ISSUE OF NEW UNITS PURSUANT TO THE
ESR-REIT DISTRIBUTION REINVESTMENT PLAN**

ESR Funds Management (S) Limited, as manager of ESR-REIT (the “**Manager**”), wishes to announce that 6,686,982 new units in ESR-REIT (“**Units**”) will be issued today at an issue price of S\$0.4018 per Unit pursuant to the ESR-REIT Distribution Reinvestment Plan in respect of the distribution of 0.662 cents per Unit for the period from 1 April 2020 to 30 June 2020 (the “**2Q2020 Distribution**”).

The aforementioned new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited at 9.00 a.m. today. The new Units will, upon issue and listing, rank *pari passu* in all respects with the existing Units in issue. Following the issue of the new Units, the total number of Units in issue is 3,543,157,293.

Eligible unitholders of ESR-REIT (“**Unitholders**”) who did not elect to participate in the ESR-REIT Distribution Reinvestment Plan and Unitholders with registered addresses outside Singapore who did not provide an address in Singapore to The Central Depository (Pte) Limited will receive all of their entitlements to the 2Q2020 Distribution in cash today.

ESR-REIT invests in quality income-producing industrial properties and as at 30 June 2020 holds interest in a diversified portfolio of 57 properties located across Singapore, with a total gross floor area of approximately 15.1 million square feet and an aggregate property value of S\$3.1 billion¹. The properties are in the following business sectors: Business Park, High-Specs Industrial, Logistics/Warehouse and General Industrial, and are located close to major transportation hubs and key industrial zones island-wide.
