On 29 May 2026, Lippo Limited ("LL") distributed all of its shares held in Skyscraper Realty Limited ("SRL") by way of a distribution in specie to its shareholders on a pro rata basis (the "DIS") and ceased to be the holding company of SRL. Accordingly, LL is no longer deemed (through SRL) to have an interest in the 96,473,203 ordinary shares in the capital of TIH Limited ("Shares") in which KUL (as defined below) has an interest.

LCR is the holding company of Rickon Holdings Limited ("RHL"). RHL is the holding company of Tamsett Holdings Limited ("THL"). THL is the holding company of Kaiser Union Limited ("KUL"). KUL holds a direct interest in 96,473,203 Shares. Accordingly, immediately before the DIS, LL was deemed to have an interest in the 96,473,203 Shares in which KUL has an interest.

After the DIS, LL is no longer deemed (through SRL) to have an interest in the 96,473,203 Shares in which KUL has an interest.
