

RELEASE OF ANNOUNCEMENT BY A SUBSIDIARY ON THE INDONESIA STOCK EXCHANGE - INFORMATION DISCLOSURE OF CERTAIN SHAREHOLDER IN RELATION TO REDEMPTION OF SHARES IN SUBSIDIARY

The board of directors ("Board") of Wilton Resources Corporation Limited (the "Company") wishes to inform shareholders of the Company that PT Wilton Makmur Indonesia TBK ("PT WMI"), the Company's subsidiary listed on the Indonesia Stock Exchange ("IDX"), had on 17 August 2021, released an announcement on the IDX entitled "Information Disclosure of Certain Shareholders" ("IDX Announcement").

The IDX Announcement is required of PT WMI as a listed company on the IDX, pursuant to Financial Services Authority Number 60 / POJK.04 / 2015. The IDX Announcement contains, *inter alia*, the disclosure of information of certain shareholder of PT WMI, namely Wilton Resources Holdings Pte. Ltd. ("WRH") (a wholly-owned subsidiary of the Company), in respect to WRH's redemption of 50,000,000 shares of PT WMI, following the maturity of a share repurchase agreement ("Shares Redemption"). The Company's effective shareholding interest in PT WMI has increased from 89.99% to 90.31% immediately after the Shares Redemption.
