TRANSFER OF STAPLED SECURITIES IN ASCOTT RESIDENCE TRUST UNDER **RESTRICTED STAPLED SECURITY PLAN AND** PERFORMANCE STAPLED SECURITY PLAN

Ascott Residence Trust Management Limited (the "Manager"), as manager of Ascott Real Estate Investment Trust ("Ascott Reit"), wishes to announce that the Manager has transferred 400,118 stapled securities in Ascott Residence Trust ("Stapled Securities") from its stapled securityholding to its key management personnel and eligible employees under the Restricted Stapled Security Plan ("RSSP") and Performance Stapled Security Plan ("PSSP").

PSSP and RSSP are the performance-based variable equity-based component of the remuneration for the key management personnel and eligible employees of the Manager pursuant to which Stapled Securities are awarded. Stapled Securities are awarded as part of the remuneration with the view of promoting alignment of the interests of key management personnel and eligible employees with those of the stapled securityholders.

Prior to the transfer, the Manager held an aggregate of 191,579,657 Stapled Securities, which constitute approximately 6.21% of the total Stapled Securities in issue. Following the above transfer, the Manager's stapled securityholding is reduced to an aggregate of 191,179,539 Stapled Securities, which constitute approximately 6.20% of the total Stapled Securities in issue.
