#### Update of Interim Judicial Management Application - Appointment of Interim Judicial Managers

*Unless otherwise defined herein or the context otherwise requires, all capitalised terms shall have the same meanings as defined in the previous announcements dated 5 August 2024, 7 August 2024, 14 August 2024, 17 August 2024, and 19 August 2024.*

Further to the announcement of Hatten Land Limited (the “**Company**”) dated 5 August 2024 informing that applications have been filed in the General Division of the High Court of Singapore (“**Court**”) to place the Company under judicial management (“**JM Application**”) and for interim judicial managers to be appointed pending the determination of the JM Application (“**IJM Application**”) (collectively the “**Applications**”), the Company wishes to announce that orders were granted by the Court today approving the IJM Application.

Messrs Tan Wei Cheong and Lim Loo Khoo care of Deloitte & Touche Financial Advisory Services Pte. Ltd. have been appointed as the Joint and Several Interim Judicial Managers of the Company.

A case conference for the JM Application will be held in the Court on 29 August 2024 at 2:30pm.

The trading suspension in respect of the shares of the Company called on 6 August 2024 continues.

The Company will make further announcements in relation to the above as appropriate in due course and on any other material developments as and when necessary.
