As part of the Company's management development, the Board has also appointed Mr Han Meng Kwang as Chief Operating Officer of the Group with effect from 1 July 2020. He will also continue with his current responsibilities as General Manager of Automated Manufacturing Solutions Pte Ltd, a wholly owned subsidiary of the company.

The Board would like to thank Mr Lim Chin Tong for his past contributions and wish him a happy retirement. We would also like to congratulate Chin Hong and Meng Kwang on their new appointments.
