ISSUE PRICE OF NEW UNITS PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE DISTRIBUTION PERIOD FROM 1 JANUARY 2019 TO 31 MARCH 2019

Singapore, 3 May 2019 - Frasers Commercial Asset Management Ltd., in its capacity as manager of Frasers Commercial Trust ("**FCOT**", and as manager of FCOT, the "**Manager**"), wishes to announce that further to the announcement dated 23 April 2019 in relation to the application of the distribution reinvestment plan ("**DRP**") to the distribution of 2.4000 cents per unit in respect of units in FCOT ("**Unit**") for the period from 1 January 2019 to 31 March 2019 (the "**Distribution**"), the issue price of the new Units to be issued under the DRP in respect of the Distribution is S\$1.4551 per Unit (the "**Issue Price**").

The Issue Price represents a 1.0% discount to the volume-weighted average traded price per Unit for all trades on Singapore Exchange Securities Trading Limited (the "**SGX-ST**") on 3 May 2019, the Market Day¹ immediately following the books closure date on 2 May 2019.

The Notices of Election² are expected to be despatched to all eligible Unitholders on or around 8 May 2019. The Manager will announce further details about the despatch of the Notices of Election in due course.
