The Fund has been approved by the Monetary Authority of Singapore under the Enhanced-Tier Fund Tax Scheme (hereinafter referred to as an “**Enhanced-Tier Fund**”) pursuant to Section 13U of the Income Tax Act 1947 (“**Income Tax Act**”) and the relevant regulations with effect from 24 September 2021.

The above tax exemption status will be for the life of the Fund, provided the Fund continues to meet all conditions and terms set out in the relevant MAS circular(s) and the relevant legislation under the Income Tax Act.

Distributions made by the Enhanced-Tier Fund should be exempt from Singapore income tax in the hands of Unitholders.
