- b) the Board's confirmation that the Waiver will not be in contravention of any laws and regulations governing the Company and its constitution (or the equivalent in the Company's country of incorporation); and
- c) issuance of the Company's annual report to shareholders and the SGX-ST by 15 April 2020.

(the "Waiver Conditions").

In addition, the Company's indicative timeline to convene its AGM for FY2019 is as follows:-

The Board confirms that:-

- (i) the Company has fulfilled all of the Waiver Conditions;
- (ii) the Waiver will not be in contravention of any laws and regulations governing the Company and its constitution (or the equivalent in the issuer's country of incorporation); and
- (iii) the Company will issue its FY2019 annual report to shareholders and the SGX-ST by 15 April 2020.

The Company will continue to monitor the COVID-19 situation and should there be a need to make further changes to the AGM date, the Company will announce promptly via SGXNet.

Trading of the Company's securities on the SGX-ST has been voluntarily suspended by the Company on 28 February 2018.
