1. Completion of Allotment and Issuance of Shares pursuant to the conversion of the Tranche 1 Notes

The Board of Directors (the "**Board**") of Magnus Energy Group Ltd. (the "**Company**") wishes to announce that an aggregate amount of S\$10,000,000 of the Tranche 1 Notes (Certificate Nos. 1 to 200) has been fully issued, converted and completed on 27 August 2015.

2. Issuance of the Tranche 2 Notes

The Board of the Company also wishes to announce that an aggregate amount of S\$3,000,000 of the Tranche 2 Notes (Certificate Nos. 201 to 260) has been duly issued to the Subscriber as at 12 October 2015 in accordance with the terms and conditions of the Notes Issue.

3. Allotment and issue of Shares pursuant to the conversion of the Tranche 2 Notes

The converted Notes, with an aggregate principal value of S\$300,000 will be converted into 44,776,119 Conversion Shares at the Floating Conversion Price of S\$0.0067 for each Conversion Share on 12 October 2015. An aggregate amount of S\$1,300,000 of the Tranche 2 Notes has been converted as of 12 October 2015.

The Floating Conversion Price of S\$0.0067 was determined by taking 90% of the average of the traded volume weighted average prices per share for any three (3) consecutive Trading Days as selected by the Subscriber during the 30 Trading Days immediately preceding the relevant Conversion Notices dated, 12 October 2015.
