("Centurion Properties") is a wholly-owned subsidiary of Centurion Global. Thinkpac Limited ("Thinkpac") is a wholly-owned subsidiary of Centurion Properties.

Thinkpac has transferred its 10,000,000 shares in the Company to Centurion Properties (the "Transaction").

Mr Loh is, therefore, deemed to be interested in:

(a) Before the Transaction:

- (i) 435,756,126 shares held by Centurion Properties; and
