RYOBI KISO ADDS S\$56.3 MILLION WORTH OF NEW CONTRACTS, BRINGING TOTAL CONTRACTS SECURED SINCE 1 JANUARY 2014 TO S\$235.5 MILLION

SINGAPORE, 15 DECEMBER 2014 – Ryobi Kiso Holdings Ltd.
