On 8 November 2019, CEL Impetus Corporate Finance Pte. Ltd. issued, for and on behalf of Aier International (Singapore) Pte. Ltd. (the "Offeror"), the offer document in relation to the mandatory conditional cash offer (the "Offer") for all the issued and paid-up ordinary shares in the capital of ISEC Healthcare Ltd. other than those already owned, controlled or agreed to be acquired by the Offeror and parties acting in concert with it (the "Offer Shares").

The Offer was declared unconditional in all respects on 2 December 2019 (the "Offer Unconditional Date"), and the settlement of consideration for the Offer Shares tendered in acceptance of the Offer on or before the Offer Unconditional Date will be made within 7 business days of the Offer Unconditional Date (the "Settlement").

Professor Low tendered his shares in the Company held through his nominee, DBS Nominees (Private) Limited in acceptance of the Offer before the Offer Unconditional Date. Accordingly, immediately following the Settlement, Professor Low will cease to have any interest in the shares in the Company.

The percentage interest has been calculated based on 532,348,544 shares of the Company in issue (excluding treasury shares) as at the date of this announcement.
