On 17 July 2024, pursuant to an internal restructuring, InterBev Investment Limited ("IBIL") entered into a conditional share swap agreement ("SSA") with TCC Assets Limited ("TCCAL") pursuant to which (a) TCCAL shall transfer or procure the transfer to IBIL and/or its nominees 601,627,606 ordinary shares in the capital of Fraser and Neave, Limited ("F&N") (which represents approximately 41.30% of the total number of issued shares of F&N (excluding treasury shares) as at the date of the SSA); and (b) IBIL shall transfer to TCCAL and/or its nominees 1,130,041,272 ordinary shares (the "FPL Transfer Shares") in the capital of Frasers Property Limited ("FPL") (which represents approximately 28.78% of the total number of issued shares of FPL (excluding treasury shares) as at the date of the SSA, such shares, the "FPL Shares") (the "Proposed Share Swap").

Completion of the Proposed Share Swap has not taken place and is subject to the satisfaction of certain conditions as specified under the SSA. TCCAL therefore has a deemed interest in the FPL Transfer Shares. Following the completion of the Proposed Share Swap, TCCAL's percentage interest in the FPL Shares will increase from approximately 58.10% to approximately 86.89% (based on the total number of FPL Shares as at the date of the SSA).
