On 18 July 2024, V2Y Corporation Ltd. (the "Company") had entered into a placement agreement with Ang Wei Yang Felix, Muhammad Asyraf Bin Azman ("Asyraf") and Teng Jun Jie ("TJJ") where amongst others, Asyraf and TJJ are to extend a convertible loan facility. On 24 September 2024, the Company had submitted drawdown notices to Asyraf and TJJ to draw down a total convertible loan amount of S\$900,000. The Company has on 30 September 2024 issued and allotted 60,810,810 shares in aggregate to Asyraf and TJJ as repayment of the convertible loan.
