("mm2 Asia" "mm2 全亚影视娱乐有限公司" and together with its subsidiaries, the "Group"), today announced an exclusive insight for its shareholders. The Group will be inviting up to 250 investors to the highly anticipated "*Karen Mok Regardez World Tour 莫* 文蔚 看看世界巡回演唱会" held on 9 April 2016, 15 years since her last concert in Singapore. The intent is to allow investors to better understand and be informed on the business of concert promotion in Singapore, and the opportunities that will be unlocked regionally and in the entertainment value chain, as part of the mm2 Asia Group.

Mr Melvin Ang (洪伟才), CEO of mm2 Asia said, "Our shareholders play a significant part in the mm2 family and we want to engage them in our business. Inviting our shareholders to have a sneak preview into the business of concert promotion is vital to the Company especially after the recent announcement of the proposed acquisition of UnUsUaL, which will soon be a part of the mm2 family. The Group will continue to engage with our shareholders through various exclusive invitations and we are dedicated to keeping regular and transparent communication with our shareholders."
