The Board of Directors (the "**Board**") of ValueMax Group Limited (the "**Company**") and together with its subsidiaries, the "**Group**") is pleased to announce that both its 3-month Series 016 Issuance and 6-month Series 009 Issuance which were both launched on 16 September 2025 have closed today at 2:00 p.m. (Singapore time). Both issuances have received strong demand from investors, with the Company raising S\$21.62 million from the 3-month Series 016 Issuance and S\$15.26 million from the 6-month Series 009 Issuance. The digital securities to be issued by the Company to the subscribers of the 3-month Series 016 Issuance and the 6-month Series 009 Issuance will be listed on the ADDX digital platform on 1 October 2025.

Amongst the subscribers of the 3-month Series 016 Issuance, Mr Tan Soon Liang, Mr Yeah Chia Wei and Madam Tan Hong Yee had subscribed for S\$0.40 million, S\$0.58 million and S\$2.82 million respectively, amounting to 17.58% of the 3-month Series 016 Issuance. Mr Tan Soon Liang is an Independent Director of the company. Mr Yeah Chia Wei is a key executive of the Company, holding the designation of Chief Credit and Risk Officer, and son of Mr Yeah Hiang Nam, the Executive Chairman of the Company. Madam Tan is a controlling shareholder and wife of Mr Yeah Hiang Nam.

Amongst the subscribers of the 6-month Series 009 Issuance, Mr Tan Soon Liang, subscribed for S\$0.60 million, amounting to 3.93% of the 6-month Series 009 Issuance.

The Company will make further announcements as and when there are other material developments in respect of the CP Facility, the 3-month Series 016 Issuance and/or the 6-month Series 009 Issuance.
