

APAC Realty Limited (Company Registration No. 201319080C) (Incorporated in Singapore on 15 July 2013)

ANNUAL GENERAL MEETING OF APAC REALTY TO BE HELD ON 20 APRIL 2021

- 1. Background: APAC Realty Limited ("APAC Realty" or the "Company") refers to:
 - (a) the Notice of Annual General Meeting dated 29 March 2021, which is published on SGXNET and APAC Realty's website at <u>https://www.apacrealty.com.sg/agm</u> ("Notice of AGM");
 - (b) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for the conduct of general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
 - (c) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "**Order**") which was gazetted on 13 April 2020, and which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies;
 - (d) the announcement made by the Singapore Exchange Regulation on 7 September 2020 pursuant to the Order, stating that all SGX-listed issuers have the option to conduct general meetings by electronic means until 30 June 2021, even where the issuers are permitted under the COVID-19 safe distancing regulations to hold physical meetings, to help minimise physical interactions and COVID-19 transmission risks; and
 - (e) the Joint Statement by the Accounting and Corporate Regulatory Authority, the Monetary Authority of Singapore and the Singapore Exchange Regulation issued on 13 April 2020 (as updated on 27 April 2020, 22 June 2020 and 1 October 2020) which included a checklist to guide listed and non-listed entities on the conduct of general meetings during the period when safe management measures are in place.
- Date, time and conduct of Annual General Meeting: The Company is pleased to announce that pursuant to the Order, the Annual General Meeting of APAC Realty ("AGM") will be convened and held by way of electronic means on <u>Tuesday, 20 April 2021 at 10.00 a.m. (Singapore Time)</u>.
- Notice of AGM and proxy form: The Notice of AGM and proxy form will be sent to Shareholders of APAC Realty solely by electronic means via publication on the SGXNET and APAC Realty's website at <u>https://www.apacrealty.com.sg/agm</u>. Printed copies of these documents will <u>not</u> be sent to Shareholders.
- 4. **No personal attendance at the AGM**: In light of the COVID-19 outbreak in Singapore, the Company will be conducting its AGM by way of electronic means pursuant to the Order as part of its efforts to minimise physical interactions and COVID-19 transmission risks.
- 5. **Participation at the AGM electronically**: Shareholders may participate at the AGM by:
 - (a) observing and/or listening to the AGM proceedings via "live" audio-and-visual webcast via their mobile phones, tablets or computers or "live" audio-only stream via telephone;
 - (b) submitting questions in advance of the AGM; and
 - (c) appointing the Chairman of the AGM ("**Chairman**") as proxy to attend, speak and vote on their behalf at the AGM.

Details of the steps for pre-registration, pre-submission of questions and voting at the AGM are set out in the **Appendix** to this announcement.

6. Persons who hold Shares through relevant intermediaries:

- (a) Persons holding shares in APAC Realty ("Shares") through Central Provident Fund ("CPF") and Supplementary Retirement Scheme ("SRS") ("CPF/SRS investors") who wish to participate in the AGM by (i) observing and/or listening to the AGM proceedings via "live" audio-and-visual webcast or "live" audio-only stream; and (ii) submitting questions in advance of the AGM, should follow the steps for pre-registration and pre-submission of questions set out in the Appendix. CPF/SRS investors who wish to vote should approach their respective CPF Agent Banks or SRS Operators to submit his/her vote by 10.00 a.m. on 9 April 2021, being 7 working days before the date of the AGM.
- (b) Persons holding Shares through relevant intermediaries (other than CPF/SRS investors) who wish to participate in the AGM by (i) observing and/or listening to the AGM proceedings via "live" audio-and-visual webcast or "live" audio-only stream; (ii) submitting questions in advance of the AGM; and/or (iii) appointing the Chairman as proxy to attend, speak and vote on their behalf at the AGM, <u>should contact the relevant intermediary through which they hold such Shares as soon as possible, no later than 10.00 a.m. on 9 April 2021</u> (being 7 working days before the date of the AGM) in order to make the necessary arrangements for them to participate in the AGM.

A "relevant intermediary" means:

- a banking corporation licensed under the Banking Act, Chapter 19 of Singapore, or a wholly-owned subsidiary of such a banking corporation, whose business includes the provision of nominee services and who holds shares in that capacity;
- (ii) a person holding a capital markets services licence to provide custodial services for securities under the Securities and Futures Act, Chapter 289 of Singapore, and who holds shares in that capacity; or
- (iii) the Central Provident Fund Board ("CPF Board") established by the Central Provident Fund Act, Chapter 36 of Singapore, in respect of shares purchased under the subsidiary legislation made under that Act providing for the making of investments from the contributions and interest standing to the credit of members of the Central Provident Fund, if the CPF Board holds those Shares in the capacity of an intermediary pursuant to or in accordance with that subsidiary legislation.

APPENDIX

Steps for pre-registration, pre-submission of questions and voting at the AGM:

Shareholders will be able to observe and/or listen to the AGM proceedings through a "live" audio-andvideo webcast or "live" audio-only stream by pre-registering, submit questions in advance of the AGM and vote by appointing the Chairman of the AGM ("**Chairman**") as proxy to attend, speak and vote on their behalf at the AGM.

To do so, they will need to complete the following steps:

		Following the verification, authenticated persons will receive a confirmation email which will contain user ID and password details, as well as the link to access the "live" audio-and-visual webcast and a toll-free telephone number to access the "live" audio-only stream of the AGM proceedings.

		Answering questions : The Company will answer all substantial and relevant questions during the AGM through the "live" audio-and-visual webcast or "live" audio-only stream. However, as there may not be sufficient time to address all such questions during the AGM itself, the Company may also publish responses to questions which the Company is unable to address during the AGM on APAC Realty's website and on SGXNET prior to the AGM.
		Minutes of AGM : The Company will, within one month after the date of the AGM, publish the minutes of the AGM on APAC Realty's website and on SGXNET, and the minutes will include the responses to substantial and relevant questions referred to above.

Submission of proxy form to vote	Appointment of Chairman as proxy : Shareholders (whether individual or corporate) who wish to vote on the resolutions to be tabled at the AGM must appoint the Chairman as their proxy to attend, speak and vote on their behalf at the AGM, in accordance with the instructions on the proxy form.
		Specific voting instructions to be given : Where Shareholders (whether individual or corporate) appoint the Chairman as their proxy, they must give specific instructions as to voting, or abstentions from voting, in respect of a resolution in the proxy form, failing which the appointment of the Chairman as proxy for that resolution will be treated as invalid.
		Submission of proxy forms : Proxy forms must be submitted in the following manner:

		A Shareholder who wishes to submit a proxy form via email must first download, complete and sign the proxy form, before (i) submitting it by post to the address provided above, or (ii) scanning and sending it by email to the email address provided above.

		CPF/SRS investors who wish to appoint the Chairman as proxy should approach their respective CPF Agent Banks or SRS Operators to submit their votes by 10.00 a.m. on 9 April 2021 (being 7 working days before the date of the AGM).
		Other persons holding Shares through other relevant intermediaries who wish to vote should approach his/her relevant intermediary as soon as possible to specify voting instructions, no later than 10.00 a.m. on 9 April 2021 .
		A shareholder may withdraw an instrument appointing the Chairman by sending an email to <u>ir@apacrealty.com.sg</u> to notify the Company of the withdrawal, at least 72 hours before the time for holding the AGM.
