Mr Ng Cheng Huat has entered into a sale and purchase agreement (the "SPA"), pursuant to which he has agreed to sell 4,000,000 shares in Metech International Limited (the "Sale Shares") for an aggregate consideration of S\$480,000.

Under the SPA, the sale of the Sale Shares will occur over multiple tranches, with the first tranche expected to take place after 29 December 2023. As at the date of this notification, no Sale Share has been transferred to or paid for by the purchaser. Mr Ng has agreed, subject to applicable laws, to exercise the voting rights attached to the Sale Shares in accordance with the purchaser's instructions.

The percentages of shares held immediately before the transaction and immediately after the transaction (as indicated above) were calculated based on 151,555,655 shares in Metech International Limited.
