



**ANNOUNCEMENT**  
**REVALUATION IN COMPLIANCE WITH GROUP ACCOUNTING POLICY**

**1. INTRODUCTION**

The Board of Directors of Malaysia Smelting Corporation Berhad (MSC) is pleased to announce that the Board had on 22 February 2019 approved the incorporation of the net gain arising from the fair value adjustment of the land and buildings to the financial statements of MSC Group.

**2. PURPOSE OF VALUATION**

The valuation was carried out pursuant to MSC Group's accounting policy.

**3. AMOUNT OF INCREASE IN VALUE**

The net gain arising from fair value adjustment of the land and buildings was RM2.9 million.

**4. EFFECTS OF VALUATION**

The recognition of the net gain arising from fair value adjustment of the land and buildings will increase the net assets per share of MSC Group by 0.7 sen for the financial year ended 31 December 2018.

**5. DETAILS OF THE VALUATIONS**

The details of the revaluation are set out in Appendix I attached.
