ISSUANCE AND ALLOTMENT OF NEW SHARES PURSUANT TO THE MIT PERFORMANCE SHARE PLAN

The Board of Directors of Manufacturing Integration Technology Ltd (the “**Company**”) refers to the Company’s announcement dated 1 July 2020 in relation to the grant of share awards pursuant to MIT Performance Share Plan (“**PSP**”).

Further to the announcement, the Company is pleased to announce the issuance and allotment of 500,000 new ordinary shares (the “**New Shares**”) to an Executive Director and Chief Executive Director of the Company, Mr Lim Chin Hong, on 1 July 2022, for the vesting of 2nd tranche of the shares under the PSP.

The New Shares issued rank *pari passu* in all respects with the existing issued shares of the Company and are expected to be listed and quoted on the Singapore Exchange Securities Trading Limited on 6 July 2022.

Following the issuance and allotment of New Shares, the total number of issued shares of the Company has increased from 240,612,470 shares to 241,112,470 shares.
