**Commercial & Office Developments:** Rounding out the latest additions to the order book are contracts for commercial and office building projects, reflecting continued private-sector demand and confidence in the Group's capabilities.

The order book provides the Group with significant earnings visibility through 2027 and beyond, underpinned by its track record in project delivery, with progressive financial contribution expected over the next two to three years, barring unforeseen circumstances.

Ltd. further enhances scale, provides a larger order book, and the capacity to tender for larger, more complex projects.

Ever Glory diversified into property investment and development in 2023 through Ever Capital Pte. Ltd. Current projects include a freehold residential development in Geylang and a food factory development at Mandai Estate.

The Group holds ISO 9001:2015, ISO 45001:2018 and bizSAFE Star accreditations, demonstrating its commitment to quality management and workplace safety excellence.
