### **NOTIFICATION ON ASSOCIATED COMPANY**

Noble Group Limited (the “**Company**”) wishes to announce that on 14 May 2014, its wholly-owned subsidiary, Noble Chemicals Limited (“**Noble Chemicals**”) has transferred all the shares (the “**Share Swap**”) held by Noble Chemicals in Novant Chemicals Limited (“**Novant Chemicals**”), being 20% of the issued and paid up share capital of Novant Chemicals, to Novant Limited (“**Novant Limited**”). Novant Limited was incorporated on 5 March 2014 with a book value of HK\$3,833 at the time of incorporation.

Following the Share Swap, (i) Noble Chemicals ceased to have a direct shareholding interest in Novant Chemicals and holds a direct shareholding interest of 20% in Novant Limited; (ii) Novant Limited became an associated company of the Company; and (iii) Novant Chemicals became a 100% wholly-owned subsidiary of Novant Limited.

No consideration was paid for the Share Swap between Noble Chemicals and Novant Limited.

The above transaction does not amount to a discloseable transaction for the purposes of Chapter 10 of the SGX-ST Listing Manual.
