The board of directors (the "**Board**" or "**Directors**") of 9R Limited (the "**Company**") refers to the Company's previous announcements dated 14 July 2023, 3 December 2023 and 5 January 2024 (together, the "**Announcements**") and the circular dated 14 December 2023 in relation to the proposed acquisition of (i) Lavish Pearl Sdn Bhd; (ii) Booming Gain Sdn Bhd; (iii) Redbox (1st Avenue) Sdn Bhd; (iv) Sunlight Ventures Sdn Bhd; (v) Lovely Pyramid Sdn Bhd; (vi) Majestic Glory Sdn Bhd; and (vii) Cheer Bonanza Sdn Bhd as a major transaction.

The Board is pleased to announce that the Company has, on 9 January 2024, received the listing and quotation notice (the "**LQN**") from the Singapore Exchange Securities Trading Limited (the "**SGX-ST**") for the listing and quotation of the Consideration Shares and the Earn-Out Shares subject to the compliance with the SGX-ST's listing requirements.
3. The LQN from the SGX-ST is not to be taken as an indication of the merits of the Consideration Shares, the Earn-Out Shares, the Proposed Acquisition, the Company, its subsidiaries and their securities.
4. The Company will keep the shareholders informed of any further development on the Proposed Acquisition and the Proposed Allotment by way of further announcement(s) as appropriate or when there are material developments in respect of the same.
5. Shareholders and potential investors are advised to exercise caution when dealing or trading in Shares. The Proposed Acquisition is subject to the fulfilment of conditions precedent and conditions subsequent under the SPA. There is no certainty or assurance that the Proposed Acquisition will be completed or that no changes will be made to the terms thereof. Shareholders and potential investors are advised to read this announcement and any further announcements by the Company carefully.
