PROPOSED RENOUNCEABLE NON-UNDERWRITTEN RIGHTS ISSUE OF UP TO 5,822,280,292 NEW ORDINARY SHARES IN THE CAPITAL OF THE COMPANY – RECEIPT OF LISTING AND QUOTATION NOTICE

The Board of Directors (the “**Board**”) of Cedar Strategic Holdings Ltd. (the “**Company**”, and together with its subsidiaries, the “**Group**”) refers to:

(collectively, the “**Announcements**”).

Unless otherwise defined, all capitalised terms shall bear the same meanings ascribed to them in the Announcements.

The Board is pleased to announce that the Company has on 12 August 2016, today, received the listing and quotation notice for the listing and quotation of 5,822,280,292 Rights Shares at the Issue Price on Catalist pursuant to the Rights Issue.

The issue of the listing and quotation notice by the SGX-ST is subject to the Company’s compliance with the SGX-ST’s listing requirements.

The issue of the listing and quotation notice by the SGX-ST is not to be taken as an indication of the merits of the Rights Issue, the Rights Shares, the Company and/or its subsidiaries and their securities.
