PAYMENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN ASCOTT RESIDENCE TRUST

Ascott Residence Trust Management Limited (the “**Company**”), as manager of Ascott Residence Trust (“**Ascott REIT**”), wishes to announce that a total of 2,217,752 units in Ascott REIT (“**Units**”) have been issued at an issue price of S\$1.2005 per Unit to the Company as partial payment of the base fee (the “**Base Fee**”) for the period from 1 January 2019 to 31 March 2019 (both dates inclusive).

The balance of the Base Fee of S\$966,518 (excluding applicable goods and services tax) was paid in cash. The aforesaid Base Fee are computed in accordance with the provisions stipulated in the deed of trust dated 19 January 2006.

With the above-mentioned issue of Units, the Company holds an aggregate of 187,545,049 Units, representing 8.623% of the total number of Units in issue of 2,174,776,790.
