## SINGHAIYI GROUP LTD. – ZERO COUPON CONVERTIBLE BONDS DUE 2014

Subject to the requirements of The Central Depository (Pte) Limited (the "**Depository**"), where a Bondholder is shown on the Register at the close of business on **27 October 2014** and has not (i) exercised his Conversion Right by the Expiration Date, or (ii) previously redeemed, converted or purchased and cancelled his Convertible Bonds, the principal amount of Convertible Bonds available in the "Free Balance" of the securities account(s) of the Bondholder on the Maturity Date will be redeemed in accordance with the Terms and Conditions.

#### 4. CLOSED PERIOD

No Bondholder may require the transfer of a Convertible Bond to be registered during the period of **27 October 2014 to 9 November 2014**.
