This announcement contains important information of interest to the beneficial owners of the Shares in the Sub-Funds. All depositaries, custodians and other intermediaries receiving this announcement are requested to promptly forward this announcement to such beneficial owners.

Following the merger of Lyxor International Asset Management and Lyxor Asset Management into Amundi Asset Management on 1 June 2022, the Board of Directors of the Fund has decided to change the names of the Sub-Funds in the following manner, with effect from 11 October 2023 (the “Effective Date”):
