Tan Yong Nang is the Sole Member of Great Alpha Investments Limited ("Great Alpha"). He is the settlor and investment power holder of The Great Delta Trust ("Family Trust"). As an investment power holder, he is entitled to direct the trustee of the Family Trust to procure to the best of its ability that the directors of Great Delta Investments Limited (an entity owned by Family Trust) act in accordance with his instructions in relation to the investments of the Family Trust. The beneficiaries of the Family Trust are his wife and children .
 By virtue of Section 4 of the SFA, Tan Yong Nang is deemed to have an interest in the shares of the Company owned by Great Alpha, Great Delta and the Family Trust.
 Following the vesting of the share awards, Great Alpha holds 41,331,991 shares in the capital of the Company. Great Delta held holds 53,000,000 shares in the capital of the Company .
 Tan Yong Nang was also deemed to have an interest in 5,631,069 shares , in a joint account with his wife (through their client account with a financial institution).
