SERIES 011, SERIES 012 AND SERIES 013 DIGITAL SECURITY TOKENS
TO BE LISTED ON THE "ADDX" SECURITY TOKEN TRADING PLATFORM UNDER ITS
S\$100,000,000 UNSECURED COMMERCIAL PAPER PROGRAMME (THE "PROGRAMME")**

*Reference is made to the announcement of MoneyMax Financial Services Ltd. (the "**Company**") dated 9 January 2023 in relation to the establishment of the Company's Programme (the "**CP Programme Announcement**") and the announcement of the Company dated 24 September 2024 in relation to the update of the Company's Programme. Unless otherwise defined, all capitalised terms used herein shall have the same meanings as ascribed to them in the CP Programme Announcement.*

The Board is pleased to announce that the Company has today launched its:

- (i) 11th series of Tokens under the Programme (the "**Series 011 Tokens**"), which will bear an interest rate of 4.65% per annum and will mature on a date falling on the expiry of 3 months from the date of issuance of the Series 011 Tokens;
- (ii) 12th series of Tokens under the Programme (the "**Series 012 Tokens**"), which will bear an interest rate of 4.80% per annum and will mature on a date falling 364 days from the date of issuance of the Series 012 Tokens, and
- (iii) 13th series of Tokens under the Programme (the "**Series 013 Tokens**"), which will bear an interest rate of 4.65% per annum and will mature on a date falling on the expiry of 6 months from the date of issuance of the Series 013 Tokens.

The Series 011 Tokens, the Series 012 Tokens and the Series 013 Tokens will be issued to accredited investor(s) and institutional investor(s) and listed on the ADDX Exchange.

The Company is expected to raise:

- (i) between S\$40 million to S\$50 million in aggregate from the Series 011 Tokens;
- (ii) between S\$15 million to S\$20 million in aggregate from the Series 012 Tokens, and
- (iii) between S\$3 million to S\$10 million in aggregate from the Series 013 Tokens,

the above amount of which may be varied at the sole and absolute discretion of the Company.



The Company will make further announcements as appropriate, if and when there are material developments in relation to the Programme and the issuance of the Series 011 Tokens, the Series 012 Tokens and the Series 013 Tokens by the Company which warrant disclosure.
