**RESPONSE TO QUESTION RECEIVED FROM A SHAREHOLDER IN RELATION TO THE
ANNUAL GENERAL MEETING FOR THE FINANCIAL YEAR ENDED 31 DECEMBER 2021**

The Board of Directors of Healthway Medical Corporation Limited (the “**Company**”) and together with its subsidiaries, the “**Group**”) refers to the publishing of its Annual Report and related documents via SGXNet on 1 April 2022. The Company has received one (1) question from a shareholder by the cut-off date and time of 12 April 2022 (Tuesday) at 5.00 p.m. which substantively relate to the Annual General Meeting of the Company, and to which the Company wishes to provide its response as follow:

Question

"Can board update on the contributions received from handling vaccination and pandemic related tasks from MOHH? With the subsiding pandemic, any impact on these income streams?"

Response: The Group has been actively providing services for and/or participating in various governmental projects from time to time in our ordinary course of business over the years. To support the Government’s effort to inoculate the population and curb community transmission, the Group has been involved in supporting the MOH Vaccination and related projects arising from the COVID-19 pandemic.

While we have been focused on battling the pandemic, the Group also took active steps to forge ahead with our strategy to strengthen our chain of GP Clinics and meet the growing demand of the Primary Care sector. To this end, the Group invested in a Primary Healthcare chain to expand medical services at locations within Singapore’s commercial business district. This will position us to provide preventive care solutions, better manage chronic conditions and improve quality of life in line with the Healthier SG initiative.

Aside from the COVID-19 related projects, the Group continues to participate in various governmental projects. The school-based health screening and vaccination project in designated preschools, primary and secondary schools is one such example. Healthway Medical is also expanding its repertoire of specialist doctors and with the relaxation in border control measures, we are cautiously optimistic about the future.

We continue to look for new opportunities that are synergistic to our business and maintain a well-diversified revenue stream consisting of contributions from our Primary Healthcare and Specialist Healthcare segment.
