## NOTICE OF ASSET VALUATIONS

CBRE Limited was the independent external valuer for the said valuations.

The aggregate value of the portfolio stood at £416,220,000, an increase of 0.5% from £414,055,000 as at 30 June 2024 and 1.2% higher than the valuation of £411,140,000 as at 31 December 2023<sup>1</sup>. The values of the respective properties as on 31 December 2024 are as follows:
