ANNOUNCEMENT PURSUANT TO RULE 706A OF THE SGX-ST LISTING MANUAL

The board of directors (the **“Board”**) of Yangzijiang Maritime Development Ltd. (the **“Company”**, together with its subsidiaries, the **“Group”**) wishes to announce the incorporation of the following associated companies and the Group’s subscription of equity interests therein during the financial year ended 31 December 2025, pursuant to Rule 706A of the Listing Manual of Singapore Exchange Securities Trading Limited (the **“Listing Manual”**).

1. Incorporation of Associated Companies¹

The Group, through Jiangsu New Yangchuan Maritime Development Co., Ltd., the Company’s wholly-owned subsidiary in the People’s Republic of China (**“PRC”**), entered into cooperation arrangements with independent third parties to incorporate the following companies in the PRC. The Group subscribed for equity interests in these companies by way of capital contribution as set out below, and the companies are accounted for as associated companies of the Group.

Ltd. by virtue of board representation and/or other contractual rights and, accordingly, the investment is treated as an associate.

The above capital contributions were made by way of subscription for equity interests, have been fully paid, and were determined with reference to the registered capital and agreed equity interests of the respective associated companies. The incorporations and capital contributions were funded through internal resources and are not expected to have any significant impact on the earnings per share and net tangible assets per share of the Group for the financial year ended 31 December 2025.

None of the Directors, substantial shareholders or controlling shareholders of the Company has any interest, direct or indirect, in the incorporations other than through their respective shareholdings and directorships in the Company, as the case may be.
