SUCCESSFUL CLOSE OF VIN'S 3-MONTH SGD COMMERCIAL PAPER SERIES 003 ON DIGITAL SECURITIES PLATFORM OPERATED BY SDAX EXCHANGE

The digital securities to be issued by the Company ("**SGD CP Series 003 Tokens**") to the subscribers of the Vin's 3-month SGD Commercial Paper Series 003 will be issued on the Exchange Platform on 24 July 2026.

Amongst the subscribers for the SGD CP Series 003 Tokens, S\$0.88 million was subscribed by the Company's controlling shareholders, spouse of a director of the Company and our Executive Director and Chief Executive Officer, amounting to approximately 19.0% of the SGD CP Series 003 Tokens.

The Company will make further announcements as appropriate, if and when there are material developments in respect of the SDAX Multicurrency CP Programme and the Vin's 3-month SGD Commercial Paper Series 003.
