

INCREASE OF SHAREHOLDINGS IN SUBSIDIARY

Pursuant to Rule 704(17)(d) of the SGX-ST Listing Manual, United Industrial Corporation Limited wishes to announce that its deemed interest in subsidiary, Singapore Land Limited (“SingLand”), held through its wholly-owned subsidiaries, UIC Enterprise Pte Ltd, UIC Development (Private) Limited and UIC Investment Pte Ltd has increased from 410,713,586 (99.572%) to 410,810,608 (99.596%) shares, following UIC Enterprise Pte Ltd’s acquisition of 97,022 SingLand shares on 2 February 2015 (the “Purchase”).

The Purchase was on cash terms at a price of \$9.20 per share.
