ISSUE PRICE OF NEW UNITS PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE DISTRIBUTION PERIOD FROM 1 OCTOBER 2016 TO 31 DECEMBER 2016

Keppel REIT Management Limited, in its capacity as manager of Keppel REIT (the "**Manager**"), wishes to announce that further to the announcement dated 24 January 2017 in relation to the application of a distribution reinvestment plan (the "**DRP**") to the distribution of 1.48 cents per unit in Keppel REIT ("**Unit**") for the period from 1 October 2016 to 31 December 2016 (the "**Distribution**"), the issue price of the new Units to be issued under the DRP in respect of the Distribution is S\$1.0004 per Unit.

The issue price represents a 2% discount to the volume-weighted average traded price per Unit ("**VWAP**") for all trades on Singapore Exchange Securities Trading Limited (the "**SGX-ST**") for each of the Market Days¹ during the period of 10 Market Days prior to and ending on the books closure date on 2 February 2017. The number of Units to be issued to unitholders of Keppel REIT ("**Unitholders**") pursuant to the DRP shall be rounded down to the nearest whole Unit, fractional entitlements to be disregarded.

The Notices of Election² and Tax Declaration Forms³ (if applicable) are expected to be despatched to all eligible Unitholders on or around 6 February 2017. The Manager will announce further details about the despatch of the Notices of Election and Tax Declaration Forms in due course.

1 "**Market Day**" means a day on which the SGX-ST is open for trading in securities.

2 "**Notices of Election**" means one or more notices of election (in such form as the Manager may approve) which the Manager will, at its discretion, send to each Unitholder and through which each Unitholder may indicate whether they wish to participate in the DRP.

3 "**Tax Declaration Forms**" means the "Declaration for Singapore Tax Purposes Form A and Form B (and its annexes)" which are sent to all Unitholders except individual Unitholders.
