

DISCLOSURE PURSUANT TO RULE 728 OF THE SINGAPORE EXCHANGE SECURITIES TRADING LIMITED LISTING MANUAL SECTION B: RULES OF CATALIST ("CATALIST RULES")

The board of directors (the **"Board**") of Moya Holdings Asia Limited (the **"Company**") refers to the Company's announcement dated 8 January 2018 ("**Announcement**") in relation to the Group's facility agreements with financial institutions, setting out information required pursuant to Rule 704(33) and Rule 728 of the Catalist Rules. The Company has been informed by TIPL that it has entered into a share charge in respect of its Shares, with details as follows:
