Performance Review

Revenue

Revenue for Q3 2018 was \$16.20 million, an increase of \$2.16 million or 15.3% from \$14.04 million for Q3 2017. The increase was mainly attributed to the increase in number of patient visits compared to the same corresponding period last year.

Other items of income

Interest income

Interest income decreased by \$0.08 million or 31.7% from \$0.25 million in Q3 2017 to \$0.17 million in Q3 2018. The decrease was mainly due to the lower interest earned on fixed deposits.

Other income

Other income comprised government-paid childcare and maternity leave and government grant under the Special Employment Credit scheme.

Other income decreased by \$5,000 or 22.7% in Q3 2018. The decrease was mainly due to a lower grant amount received.

Other items of expense

Employee benefits expense

Employee benefits expense comprised remuneration paid to doctors, nurses as well as other support staff. These included salaries and wages, allowances, CPF contributions, bonuses and staff benefits.

Employee benefits increased by \$1.77 million or 47.3% from \$3.73 million in Q3 2017 to \$5.50 million in Q3 2018. The increase was mainly due to an increase in staff salaries and provision of staff bonuses.

Cost of share-based payments to employees

Share-based payments to employees related mainly to the options and performance shares that were granted on 11 May 2017 under the Company's employee share option scheme and the performance share plan respectively. It decreased by \$6,000 or 4.3% in Q3 2018.

Performance Review (cont'd)

Operating lease expense

Operating lease expense increased by \$0.03 million or 7.0% from \$0.46 million in Q3 2017 to \$0.49 million in Q3 2018. The increase was due to a new operating lease that was effected in May 2018.

Other operating expenses

Other operating expenses comprised mainly advertising and marketing expenses, depreciation, insurance, legal and professional fees and laboratory consumables and services.

Other operating expenses increased by \$0.02 million or 1.5% from \$0.99 million in Q3 2017 to \$1.01 million in Q3 2018. The increase was mainly due to an increase in overhead expenses incurred by a subsidiary, Stem Med Pte. Ltd. ("Stem Med").

Share of results of associate

The Group's share of loss after tax of its associate, Hong Kong Integrated Oncology Centre Holdings Limited ("**HKH**") was \$0.29 million in Q3 2018 as compared to \$0.39 million in Q3 2017, which represented a decrease of \$0.10 million or 27.4%.

Income tax expense

Income tax expense increased by \$0.10 million or 5.9% from \$1.67 million in Q3 2017 to \$1.77 million in Q3 2018 due to higher profits in Q3 2018. The effective tax rate for Q3 2018 and Q3 2017 were 19.8% and 19.5% respectively.

Profit after tax

The Group recorded profit after tax of \$7.20 million in Q3 2018 as compared to \$6.92 million in Q3 2017, an increase of \$0.28 million or 3.9%. This was mainly due to an increase in revenue, partially offset by a decrease in interest income and an increase in employee benefits expense and operating lease expense.

Review of the Group's financial position

Non-current assets

The Group's non-current assets comprised plant and equipment, investment in associate and prepaid operating expenses. Non-current assets decreased by \$0.66 million which was mainly attributable to a decrease in the carrying amount of our investment in associate pursuant to taking up the share of loss of associate of \$0.69 million for YTD 2018, offset by an increase in the carrying amount of plant and equipment of \$0.03 million.

Review of the Group's financial position (cont'd)

Current assets

Current assets comprised inventories, prepaid operating expenses, trade and other receivables and cash and short-term deposits. Current assets decreased by \$7.14 million which was attributable to the decrease in cash and short-term deposits and trade and other receivables of \$5.10 million and \$3.11 million respectively, partially offset by an increase in inventories and prepaid operating expenses of \$0.12 million and \$0.95 million respectively.

The decrease in cash and short-term deposits and trade and other receivables was mainly due to a decrease in YTD 2018 revenue.

Current liabilities

Current liabilities comprised trade and other payables, other liabilities and income tax payable. Current liabilities decreased by \$0.39 million. Income tax payable decreased by \$1.33 million due to payment of income tax for the financial year ended 31 December 2017, offset against income tax provision in respect of the first three quarters of 2018. Trade and other payables increased by \$0.14 million mainly due to higher GST and trade payables. Other liabilities increased by \$0.80 million due to higher accrued operating expenses.

Non-current liabilities

Non-current liabilities comprised other liabilities and loan from non-controlling shareholder to a subsidiary. Non-current liabilities increased by \$1.65 million mainly due to additional loan (before any unwinding of discount adjustment) of \$2.00 million from StemCord Pte Ltd ("StemCord") to Stem Med. The Company and StemCord had granted additional loans (before any unwinding of discount adjustment) amounting to \$3.00 million and \$2.00 million respectively to Stem Med, thus bringing total loans (before any unwinding of discount adjustment) from the Company and StemCord to \$5.40 million and \$3.60 million respectively. As at 30 September 2018, the loan from StemCord after taking into account the unwinding of discount adjustment was some \$2.88 million.

Equity attributable to owners of the Company

The decrease was mainly attributable to final and interim dividends paid to shareholders in respect of FY2017 and the financial year ending 31 December 2018 ("**FY2018**") respectively, offset by profits earned during the year.

Non-controlling interests

This is related to the:-

- (i) 43%, 48.7% and 65.8%⁽¹⁾ non-controlling interests' share in the net equity of Stem Med, Stem Med Indonesia Pte. Ltd. and DrSG Cellular Wellness Pte. Ltd. ("**DrSG**") respectively;
- (ii) 25% non-controlling interests' share in the net equity of TalkMed Chongging Pte. Ltd.; and
- (iii) 43% non-controlling interests' share in the net equity of CellVec Pte. Ltd...

Note:-

(1) Stem Med owns 60% of DrSG. By virtue of the Company's 57% interest in Stem Med, the Company effectively owns 34.2% of DrSG and the remaining 65.8% falls within the definition of non-controlling interests.

Review of the Group's cash flows

Operating activities

Net cash flows from operating activities for Q3 2018 amounted to \$7.25 million. This comprised operating cash flows before changes in working capital of \$9.34 million and interest received of \$0.17 million, less net changes in working capital of \$0.07 million and income tax paid of \$2.19 million. The net increase in working capital of \$0.07 million was mainly due to an increase in inventories and prepaid operating expenses of \$0.01 million and \$0.69 million respectively, offset by a decrease in trade and other receivables of \$0.10 million and an increase in trade and other payables and other liabilities of \$0.08 million and \$0.45 million respectively.

Investing activities

Net cash flows used in investing activities of \$0.15 million for Q3 2018 was attributable to the purchase of plant and equipment by Stem Med.

Financing activities

Net cash flows used in financing activities for Q3 2018 amounted to \$10.00 million. This was attributable to the payment of interim dividends to shareholders in respect of FY2018.

Net decrease in cash and cash equivalents

The above resulted in a net decrease in cash and cash equivalents of \$2.91 million for Q3 2018. Cash and cash equivalents totalled \$65.95 million as at 30 September 2018.
